FOR ALL OIL FACILITIES IN WASHINGTON STATE



Effective July 7, 2023, **Washington Administrative Code (WAC) 173-180** introduced enhanced oil spill prevention and transfer requirements for Class 1 facilities. These regulations mandate that storage tanks and transfer pipelines constructed before the rule's effective date must implement seismic protection measures within 10 years or by the next scheduled internal API Standard 653 or 570 inspection, respectively, whichever is later.
